Exporter also agrees to indemnify ATLANTIC SHIPPING LLC and hold it harmless from and against any, and all, liability or damage ATLANTIC SHIPPING LLC may suffer as a result of Exporter providing incomplete, false or inaccurate information to ATLANTIC SHIPPING LLC. This Power of Attorney is to remain in full force and effect until revocation in writing is duly given by the Exporter to, and received by, ATLANTIC SHIPPING LLC.
