VITAL INFORMATION

Thanks for requesting a container from Atlantic Shipping LLC, An NVOCC license by the FMC bases in minnesota,

-All information requested is need at times of booking.

- We will need the customer to provide us with the below information to facilitate shipping process.

- A Passport number and copy of their ID if shipper is an individual or tax ID number if customer own a business.

- Name, address, email and phone number of the shipper and receiver or receiving company.

- A clear copy or picture of car titles, lien release and the value of each car. Also the cargo description, value and piece count.

- Make 5 copies of the titles and lien release front and back, you will keep one color copy of the title for your record and give the original and 4 copies to the driver, if shipping from Baltimore. Atlantic shipping LLC will not be held responsible for any stolen vehicles or lost titles. Communicate with the driver or clearing agent for your titles. Please ask for information on custom clearance for your port of export.

- We will prepare an NRA and power of attorney form, on the agreed terms of shipment.

- We will need an initial deposit of \$1500 before dropping the container and the balance is due upon container sailing.

- Most shipping lines have a maximum number of days you can keep the container for loading. Remember to ask at time of booking. The customer is responsible for any demurrage, detention and or roll over charges. The customer is responsible for any charges related to damage, fire, destruction of the container at their possession.

- US Customs and Border Protection Agency select containers for compliance exams, customs do not share with AtlanticShippingLLC the nature of the hold or when the container will be released. All charges are the responsibility of the shipper. Custom have the right to do random search on any container at any port in the United States at any time. There are charges for this search, which is the customer's responsibility.

Customer certify that there're no Stolen vehicles, no ammunition, dangerous goods, explosives or illegal items and of extraordinary value in this shipment.

- We encourage customers to insure their goods. If customer did not buy any insurance for their goods being shipped, in case of damages, fire or theft please understand that under maritime law we are only responsible for up to 500 US Dollars per bill of lading. Please secure yourself and take adequate insurance.

-Shipping time is approximated and ATLANTIC SHIPPING LLC is not responsible for any delays caused by highway problems, steamship line schedule changes, and vessel over-booking, technical problem in equipment or vehicles, strikes, port authorities 'rulings, Pandemic like covic 19, labor problems at the origin or destination, and other reasons beyond our control included.

-The customer is responsible for tracking their own container; tracking of containers is online. Atlantic Shipping LLC is willing to assist in tracking container if customer is facing any difficulties.

- There are extra charges if container is not paid on time. Amount depends on shipping line. Please try to pay your container on time to avoid this charges. Most shipping line need full payment at time of container departure.

We will send you a copy of the shipping instruction to verify if all the information is correct, there will be a manifest correction fee if you do not revert back on time for any changes, usually within 48 hours of receive.

- 1) CMA-CGM requires you to pay in full within 14 days of shipment sailing.
- 2) ACL/Grimaldi requires you to pay within 15 days after the sail date.
- 3) Maersk requires you to pay within 5 days of departure.
- 4) MSC requires you to pay within 15 days from sail date.
